## NOTICE INVITING AUCTION NO:- NBSTC/09/CONSTN. (C)/MALLAGURI/SLG/2024-2025(2nd Call)

Sealed auction Notice is hereby invited by the undersigned from resourceful bonafied Contractor and resourceful bonafied outsiders for the following items as mentioned in Annexure-1.

1) Old Dilapidated existing boundary wall at NBSTC, Mallaguri Depot, , Siliguri, Darjeeling.

### **Terms & Condition of Auction**

- i) It shall be deemed that all bidders have thoroughly read and understood the terms and condition of sale before bidding. It will also deemed that all the bidder have inspected the properties at NBSTC, Mallaguri Depot, , Siliguri, Darjeeling prior to auction and have satisfied themselves with the full particulars of the same. No objection or claim of any nature whatsoever shall be entertained at the conclusion of the auction.
- ii) The material will be auctioned on "As is where is basis".
- iii)The intending bidders shall have to submit Certificate of enrolment on Professional Tax (PT), up-to-date Professional Tax deposit receipt challan, Valid Pan Card ; Trade License; Voter ID Card ; ITR for latest assessment year, Goods and Service Tax (GSTIN) Registration certificate along with Identification Number under GST Act 2017; up to date GST return with the rate quoted document on the specific Format as per ANNEXURE -1.
- iv) The bidder is to quote their rate on the total cost (inclusive GST & other taxes as per norms) duly Signed by him in the self pad as per proforma given in ANNEXURE -1.
- v) The intending bidders shall have to submit an amount @ 10% of Bid Money as Security Deposit(Earnest Money) in the form of Bank Draft on any Nationalized Bank in favour of the "North Bengal State Transport Corporation", CoochBehar. No offer will be considered for unless the same is supported by the requisite amount of Bank draft as security deposit (Earnest Money) and rate Quoted shall be treated as informal.
- vi) The acceptance of the highest bid shall not be treated as the final acceptance of the bid and highest bidder shall have no claim on the property until and unless the bid money is deposited by the highest bidder in full in the shape of Bank draft (Nationalized Bank) in favour of the "North Bengal State Transport Corporation", CoochBehar
- vii) From the date of issue of the acceptance order by the Managing Director, North Bengal State Transport Corporation for removing the property sold to the purchaser to the last day for the removal of the property by the purchaser, the property at the site will remain at the risk, responsibility and expenses of the purchaser.
- viii) Each participant including the highest bidder or his authorized representative who may remain present during the opening of the sealed bid will sign an Attendance sheet. Persons not participating in the Auction sale will not be allowed to remain present during the time of opening of sealed bid.
- ix) If the highest bid in the opinion of the undersigned does not appear to be satisfactory, the undersigned reserves the right to cancel the bid process and ask for fresh bid and so on.
- x) The successful bidder shall have to deposit the full bid money within 5 days of the issue of letter of acceptance failing which his offer will be treated as cancelled with forfeiture of the Earnest Money and imposition of other penal measures as per existing orders.
- xi) On receipt of the full bid money after acceptance, the undersigned will issue order for lifting the material so auctioned to the highest bidder. The auctioned material must be removed from site within the stipulated time. In case of any damage to the public property during lifting etc the cost towards rectification / renewal of the property shall be recovered from the bidder on the basis of the estimate prepared by this office.
- xii) The security deposit will be released after successful completion of dismantling and removal of all the dismantled materials as directed by the Engineer-in-Charge on entire satisfaction of the Department. Boundary of length marked as A-B, B-C & D-E in Annexure-II will be auctioned. In case of any difficulty in finding out the dilapidated structure to be auctioned the intending bidders may contract with the concerned Executive Engineer (C), North Bengal State Transport Corporation, Cooch Behar in office hours except holiday who will extend all sorts of cooperation to the intending bidders.
- xiii) The intending bidders shall drop their sealed auction paper as referred in sl. no. (iii) in the box kept in the office of the Managing Director, NBSTC, Paribahan Bhaban, Sagar Dighi Square Cooch Behar on 23/08/2024 up to 15.00 Hrs. The sealed auction paper will be publicly opened by the undersigned in the Conference Hall Chamber NBSTC, Paribahan Bhaban, Cooch Behar on 23.08.2024 at 16:00 Hrs. in presence of the bidders or their authorized representatives if any.

- xiv) It is to mention that the site should duly be cleared including dismantling and taking out of all dismantled materials even from foundation of the structure entirely within 15(fifteen) days from the date of issue of formal order.
- xv) Extra precaution shall have to be taken by the highest bidder that no life, Govt. property and private property will damaged during dismantling and removing the materials. If so happen necessary demurrage charges, as fixed by the Department, shall have to pay to the concerned authority or person by the highest bidder.
- xvi)The bidder, at his own responsibility and risk is encouraged to visit and examine /inspected the properties at NBSTC, Mallaguri Depot, , Siliguri, Darjeeling prior to auction and its surroundings and obtain all information that may be necessary. The cost of visiting the site shall be at the bidder's own expense.
- xvii) The bidder should consider that the site is a running depot and during dismantling and removing the materials normal bus operation should not be dislocated/disturbed. In this case the work should be so arranged and the programme of work must be as adjusted as would not disturb the smooth depot operation in any way. If necessary, the programme of work may be planned beyond normal working hours with prior approval of the EIC / The Divisional Manager, NBSTC, Siliguri Division for which bidder shall not demand for any additional claim.
- xvi) The Managing Director, North Bengal State Transport Corporation, Cooch Behar is in reserve the right to accept or reject the auction partly or fully without assigning any reasons.
